Information: Seth and Kelli will help to present information on Idaho Association of Counties legislative priorities for this upcoming year. They will review the contract with IADBH and IAC for legislative services. The primary focus will be on future direction and mission of IADBH. A facilitated discussion of strengths, weaknesses, opportunities, and threats to guide IADBH members in a discussion of action moving forward from the conference. This will help align decision-making and strategic direction.

Presenter: Seth Grigg has been Idaho Association of Counties Executive Director since 2017. Seth provides IAC with overall strategic and operational oversight including legislative advocacy. Seth is well respected in his role at IAC. Seth holds a master’s in public administration degree from BSU.

Presenter: Kelli Brassfield joined IAC in 2015 as a policy advisor. Kelli carries out policy research, analysis, and reporting to enable legislative priorities to be successfully implemented. Kelli continues to provide support and assistance to multiple IAC efforts and committees. Kellie has bachelor’s in business administration.

Information: Katie will provide information on Millennium Fund resources and work that Idaho’s Department of Education (SDE) is implementing to help schools in prevention efforts around vaping and other substance use. Specific discussion will be had on SDE pilot youth well-being survey being implemented across districts this fall.

Presenter: Katie Watkins is the Healthy Students and Schools Coordinator at the Idaho Department of Education (SDE). She has been with the department for two years and prior to this position, was a teacher for 18 years in the Nampa and West Ada School Districts. She oversees student health and safety. Specifically, she oversees several grants such as the Healthy Schools grant in partnership with the Department of Health and Welfare providing funding for nurses in our school districts/charters. She also manages Millennium Fund grants such as the vape detector grant and provides quarterly PLC calls with the participating districts about prevention/intervention efforts for vaping. In partnership with Idaho State Police, SDE has educational funding for community outreach events on substance misuse topics, such as the dangers of fentanyl. Recently, SDE granted 27 school districts/charters with SRO funding. Finally, Katie is involved with the Idaho Youth Well Being Assessment and Fentanyl survey in Idaho.
